"Hitting the Trails"

at the Richmond Aqueduct Trail

What a beautiful day it was for all the participants to enjoy an autumn hike at the Richmond Aqueduct Trail on October 17th. Mike Riley led the hike by telling the story of the 200-year evolution of the Erie Canal system through the historic resources that remain in this area.

The Richmond Aqueduct Trail is part of the 30 trail system of the Wayne County Hit the Trails sponsored by Wegmans. This trail does **not** allow hunting, located at Chapman Rd. off Rte 31/High Street, Montezuma, NY 13117 One can get a passport book or download the app "Hit the Trails" on your smartphone to earn trail, mural or history badges.

The Montezuma Heritage Park consists of over 165 acres of parkland acquired by the Town of Montezuma in the 1960's to be preserved and protected. It holds many significant natural and historic resource sites along the Seneca River/Erie Canal that tell the story of New York State's Canal System from 1820 to today. Listed on the National Register of Historic Places as part of the 70-acre Seneca River Crossing Ca-



nals Historic District on the Seneca River in the towns of Montezuma and Tyre, it illustrates nearly 200 years of canal engineering. The Park is being developed and maintained by the volunteers of the Montezuma Historical Society Friends of the Park.

The trail is one of eleven nature trails in Montezuma Heritage Park that also includes several historic canal sites including Clinton's Ditch Lock 62. The former towpath trail leads to the remains of the second largest aqueduct along the Enlarged Erie Canal. Work began on the "water bridge" in 1849 consisting of building 31 arches spanning 894-1/2 feet long built to replace the hazards of crossing directly through the Seneca River by lifting the canal over it. Van Rensselaer Richmond, American Civil Engineer and politician from Lyons, NY, designed it. It was dismantled in 1917, to make way for the new Barge Canal. Today seven arches remain on the east side of Seneca River and three on the west side.



Enjoy walking the easy ½ mile trail, biking, cross-country skiing, bird watching, and fishing.


Starting the Year on the Right Foot

We strive to preserve Wayne County heritage and green spaces for the enjoyment and recreation of our future generations. Please renew your membership today.



Enlarged Lock 56 Historic Marker

TRAIL WORKS SPEARHEADS THE ADDITION OF POMEROY HISTORIC SIGN ON E-56 TRAIL

Trail Works is proud to announce placement of a Pomeroy historical canal marker at the "Poorhouse Grocery" in Lyons.

This marker was a grant in a new William G. Pomeroy Foundation program commemorating the history of important transportation canals in the United States and uses a new design and color scheme.

Up until 1918 when the now operating barge canal was opened, the Enlarged Erie Canal served as the main conduit for commerce and travel to and beyond Lyons.

Enlarged Erie Canal Lock 56 is located about two miles west of Lyons at the eastern end of Trail Works' Lock 56 trail and a short stone's throw from the barge canal. What today is known as the "Poorhouse Grocery" is next to the lock.


Built sometime after the Enlarged Erie was opened in 1849 and before 1855, the brick structure housed a grocery and chandlery as well as providing a home for the owners.

Today, Allyn Perry, who grew up and still lives there, is an enthusiastic spokesperson for its history.

Together with my wife Joan and Allyn and under the auspices of Trail Works we researched this history and

Closing the Gaps

A COMPLETED LINEAR TRAIL LINKS WAYNE COUNTY WITH NEW YORK STATE

The gaps are finally closed. After thirty years we finally have a trail across N.Y. State and Wayne County. Eighty percent of the trail is off the main highway, which makes this even more special. In 1988, I started a non-profit called E.R.I.E. (Erie's Restoration Interests Everyone) *. One of the bullets on our brochure was to establish of a linear trail across the New York State. E.R.I.E. spent the next three years clearing a path along the Erie Canal. This was done with the Shock Incarceration Camp out of Butler. The section from Stebbins Road to the Rt. 88 bridge in Newark is a section that was completed in the early 90's. Over the years this section has been improved and just last year this section was paved. Throughout the 90's and early 2000's I was on a committee that focused on closing the gaps. Over those years mileage was added but there still were plenty of gaps in the trail.



Closing the Gaps has been part of Trail Works' mission since I joined in 2008. In fact, the Black Brook section has always been a focus of Clean Sweep almost every year. I have many photos of us clearing all the invasive species that grew along the old towpath. One year we also cut out a large tree that had fallen on the trail. When it seemed that trail development was slowing to a crawl pace, Trail Works reached out to Canal Director Brian Stratton about assisting with putting in the section from Newark to Lyons. Brian came to Newark on a Saturday in November of 2011, and met with Arcadia Supervisor Dick Colacino and Trail Works board members Mark De Cracker and "Jolly Roger." In less than a week, Brian got back to us and said work would begin in the Spring.

Trail Works was again front and center in bringing attention to Closing the Gaps. We organized a bike ride from Macedon to Montezuma along the trail we were proposing in Wayne County. We had over 10 riders who participated on that ride that day for National Trails Day on June 3rd, 2017. Trail Works board member James Zeger even came up with a design for this bike ride. At the end of the ride we were treated to a chicken barbecue in Montezuma.

In the Summer of 2019, "Closing the Gaps" was coming to fruition. The trail across Wayne County was completed except for a small section that was disputed in the courts. This section was completed Fall 2020, and we now have a trail not only across Wayne County, but across the state of New York.

On January 1st, Trail Works led a successful hike with S.O.A.R. on this beautiful section of the enlarged Erie Canal.

Camp Beechwood Update

We have some good news from the park service. As many of you know, we got a tentative date of last July for them to come in and clean up the arson sites, as well as to start removing unsalvageable buildings. Aside from being short-staffed due to Covid, and Beechwood being on the back burner for so many years, they had no idea how many buildings we had anymore or where they were. Also, apparently a permit is required for each structure to be removed and also another permit to remove any hazardous material, which in our case is mostly roofing shingles. A representative came out to the park a few weeks back and we did a documented inventory together of the entire park. The Beechwood committee then e-mailed the state with a list of the buildings that we would like removed. We've heard back from our local park representative, Marcus Riehl, and the permits are being processed. There was also talk of getting it all taken care of while the ground is frozen, so the heavy equipment doesn't tear up the park. So the ball is definitely rolling now with the park service.

A list of buildings being removed from the park:

- the last two arson sites
- the pool house
- the counselor's cabin, shower, laundry, and latrine behind the pool
- the Romany building (where the new water spigot is)
- two a-frames closest to the main trail, one a-frame which is already down, pavilion with the caved in roof, and latrine in the highlands area which is the first section of a-frames
- director's cabin, which is the one set back in the field where the port-a-potty normally is
- woodshed next to the pioneer lodge and latrine on the side hill at the pioneer lodge
- everything in the eastwoods section next to Sprongs Bluff except one latrine and the pavilion.

A preliminary spot for a new parking area which will be off a new access road coming off of Lake Rd. on the west side of the park has been chosen. I'll be clearing the area as soon as the weather breaks, and the town will be putting in the road. As far as the new trails being put in, that is still up in the air as to who is going to do them and when, but they are coming.

For the last few months the town has been working on ways to accept donations directly and through the new <u>campbeechwood.com</u> website. At this time this cannot happen, but Trail Works will be discussing accepting donations for Beechwood at our February board meeting.

HOW MANY BIRDS WILL YOU FIND?

Worldwide birdwatching event starts on February 12

New York, NY, Ithaca, NY, and Port Rowan, ON—Lots of people turned to birdwatching during the past year, seeking enjoyment and relaxation. Chickadees, cardinals, finches and other birds are doing their part to lift human spirits. The 24th annual Great Backyard Bird Count (GBBC) is a great opportunity for all budding birdwatchers and bird-count veterans to use their skills. People from around the world count the birds they see for at least 15 minutes on one or more days of the count, and then enter their checklists online.

The GBBC takes place February 12 through 15.

"The GBBC is a simple, welcoming project that both new and veteran birdwatchers enjoy," says David Bonter, Co-Director of the Center for Engagement in Science and Nature at the Cornell Lab of Ornithology. "Birds are everywhere and can be counted in backyards, neighborhoods, suburban parks, wild areas, and cities. Scientists need the eyes of the world to collect information about where the birds are."

During the 2020 GBBC, birdwatchers set new records for the event, turning in nearly 250,000 lists of birds seen, from more than 100 countries, identifying nearly 7,000 of the world's estimated 10,000 bird species. Data gathered by the GBBC and other survey projects highlight changes in the numbers and distribution of wild birds over time.

Birds make us happy. "By participating in the Great Backyard Bird Count, community scientists contribute data that we use to protect birds and the places they need, today and tomorrow," said Chad Wilsey (@ChadBWilsey), Ph.D., chief scientist at National Audubon Society. "In return, studies tell us that pausing to observe birds, their sounds and movements, improve human health. Participating in the Great Backyard Bird Count is a win-win for birds and people."

This year there is a new way to send in an observation—through the Cornell Lab's free Merlin Bird ID app. If you use the app during the GBBC and save a bird you've identified, it is also counted for the GBBC. As in the past, using the eBird platform on your mobile app and computer are still great ways to enter your data. Visit our How to Participate page to learn more about entering your bird sightings.

Chimney Bluffs and Whistlewood Hike with the Black River Chapter of the ADK Mountain Club

On Saturday, March 27th, Trail Works will partner with the Black River Chapter of the ADK Mountain Club for two hikes and lunch at a local restaurant. The first hike is above the world-famous landmark Chimney Bluffs on the south shore of Lake Ontario. This is a very short trail about 1 mile in length, 2-mile RT. Chimney Bluffs has experienced some erosion, and some of the paths that were along the edge are no longer usable; therefore, you should forge a path through wooded areas.

After this adventure, we can visit a local winery or restaurant prior to moving onto the next hike through Whistle-wood which is a former Girl Scout Camp that is now part of the NYS Lakeshore Marshes Wildlife Management Area and managed by the New York State DEC. From the top of the hill, views of Beaver Creek and Lake Ontario are spectacular. This is a short 1.25-mile loop trail, wrapping up the visit by midafternoon for the return to the North Country.
