NEW POCKET PARK WELCOMES VISITORS TO LYONS

Through a New York State Canal Corporation Amenities Grant, the Town of Lyons has a new "pocket park" kiosk by the Little League field that welcomes visitors walking or cycling the Empire State Trail. Designed by Rhea Hayes from a National Parks map, a large map of the commercial area of Lyons helps trail users to find amenities and places of interest. The kiosk sign on the opposite side, also designed by Rhea, offers a tour of murals as a way to enjoy the town. A QR code will take the visitor on a mural tour, while another QR code will have a list of amenities through the Lyons Main Street Program.





Eastern Equine Virus

The eastern equine virus has been in the news a lot lately. If you are outside, whether out on the trail or just in your back yard, you could be exposed to EEE through infected mosquitos.

EEE is a rare but serious infection that causes inflammation of the brain. It can be fatal. It's most common in eastern or Gulf Coast states, but cases have been identified further west in recent years. There is no treatment for EEE, but hospitalization and supportive care may be needed.

Most people infected with EEE don't develop any symptoms. Symptoms usually occur 3 to 10 days after being bitten by an infected mosquito.



Symptoms of Eastern Equine Encephalitis (EEE) virus can vary depending on the type of illness and the person's age:

- Febrile illness: Symptoms include fever, chills, body aches, and joint pain.
- Neurologic disease: Symptoms include fever, headache, vomiting, diarrhea, seizures, behavioral changes, drowsiness, and coma.
- Mild infection: Can last one to two weeks, but you may feel tired or weak for several weeks to months.

Severe infection: Can take a few months to recover completely.

There have been no confirmed human cases of EEE in New York State thus far this year. To reduce your risk of infection, you can prevent mosquito bites and protect yourself if you live in areas where EEE circulates. Learn about this virus and how to protect yourself by checking the following link:

Beechwood State Park had a busy summer for camping, its best season yet, according to Sal Vittozzi, park manager. Sal reports that as of mid-September, the campers are still coming strong! The Boy Scouts have troops registered through the end of November as well.

Sal also shared that the "*Week of Hope*" work group spent some time this summer at Beechwood, doing general maintenance work, trimming and building trails.

In addition, they built two new campsites, one at the Pixie area at the bluff, and another in the old ash grove to the north east of the old pool area, called "Hope's Haven."





Also on the west side of Beechwood is an old "survival" shelter or "hut," which was given some love by the Week of Hope workers. Next time you are at Beechwood, be sure to check out these new areas!





Trail News and Notes

Huckleberry Swamp

Have you seen the two new bat houses (an Eagle Scout Project) in the "gathering area" here? A fun place to visit, you never know what you will find along the trail! Please remember that this trail closes for the winter.





Sanctuary at Crowfield Farm

Owner Steve Aman and Genesee Land Trust folks tell us this trail is still open for hiking, even though there is no sign out at the road at this time. You can still drive into the property and park down by the kiosk. Please drive *slowly* and be respectful of the neighboring properties.

Third Creek Trail (Shaker Tract Rd)

The bridge over Third Creek is back in place at the south end of the trail. Thanks to DEC Field Office folks on Morgan Rd in Savannah for helping with this project. Trail Works member Gary Abbott also added more trail markers once you cross the bridge heading north to help hikers stay on the trail.



Deer Creek Woods Opening Celebration (600 Lake Rd, Ontario, NY)

Hunting Seasons Are Now Open

Check the NYS DEC website for current hunting seasons as related to the trails you hike. Many state lands, wildlife management areas, and forests have different regulations and dates. Currently in Wayne County, the "*early antlerless*" season is underway as of September 14. Several other hunting seasons open Oct 1. Regular deer season opens Nov 16.





HOW TO STAY SAFE ON DOG WALKS

Check regulations if you are planning to hike any state lands. Some state parks allow hunting, such as Letchworth and also Chimney Bluffs, with special permits. See and be seen! The campers from the Week of Hope come from all over the east coast, including Virginia, Pennsylvania, Connecticut and Ohio. I have made some new connections to some wonderful people who I will continue to have contact with. It is always sad to see them go. My hope is to try to get a program with our local youth to help at the Trail of Hope. An ounce of their passion could go a long way.

Galen and Savannah Bike Ride

June 15th, 2024

Saturday June, 15th turned out to be a beautiful day for a bike ride. While I hoped for a bigger turnout, six cyclists made for a perfect day. Approaching the dirt road leg of our ride along Lockpit Road, an unaccompanied fawn emerged from the woods on our right, and crossed the road just ahead of us. Our route included part of an alternative way on which I have led through-bikers heading east along the Empire State Trail, and one that both avoids Route 31 and gives riders a quieter and more interesting view of eastern Wayne County.

The Empire State Trail was routed entirely along Rt. 31 from Brown Road to Montezuma and not through Montezuma National Wildlife Wetlands land because of an eagle nesting along the preferred off-road section. So, our ride traversed a berm overlooking a different section of Montezuma National



Wildlife Wetlands. Here, on what was once muckland used for potato production, we saw some intact and some collapsed muskrat lodges, various waterfowl, a great blue heron, and a couple of Osprey nests with screeching inhabitants. It was here that Trail Works board member Gary Abbott reminisced about his childhood at and near this exact spot, across the road from where he grew up.

We stopped where Hogback Rd. rejoined the Empire State Trail (Rt. 31) to complete the loop. Here, Sharon Van Liew, our fourth Trail Works member, shared her knowledge of and experience with Savannah Dhu. We would be able to recognize Savannah Dhu property behind the fences to our north along Rt. 31 as we travelled westward toward our starting point at Lauraville Landing. The other three participants were my wife Joan and a couple who Joan and I had first met as they checked out the signage at Lock Berlin Park a few days before the ride. They were from Arizona, nearing the end of a year's stay in Wayne County, and eager to learn about the local area.

Wayne County Public Health Confirms Human Case of West Nile Virus and Urges Residents to Practice Prevention and Protection against Mosquito Borne Illnesses

Lyons NY-Wayne County Public Health is reporting a confirmed human case of West Nile Virus. The infected resident is currently hospitalized and receiving care. West Nile Virus is spread through the bite of an infected mosquito. West Nile Virus infections occur most often during the summer and early fall. West Nile virus infections can cause serious illness and, in some cases death. According to the NYSDOH, "Most people (70-80%) who are infected with West Nile Virus show little to no symptoms." Those over the age of 50 are at the highest risk for serious illness. Symptoms of West Nile Virus may include fever, headache, body aches, skin rash, and swollen lymph nodes. More severe symptoms may include high fever, headache, neck stiffness, muscle weakness, vision loss, numbness, and paralysis.

Local health official, Diane Devlin, RN, BSN, MS Director of Public Health urges Wayne County residents to take preventative measures to protect themselves and their homes from mosquitoes. Devlin said, "The most effective way to reduce risk of infection from West Nile Virus is to prevent mosquito bites and reduce the mosquito population in and around your home." To reduce mosquito populations:

- Remove sources of standing water.
- Minimize exposures to mosquito bites by using insect repellents containing DEET, picaridin, or oil of lemon eucalyptus. While administering insect repellent, be sure to follow all label instructions. Adults should apply repellent to their own hands first then apply to children's exposed skin.
- Wear long sleeves, long pants, tuck pants into socks, and tuck shirt into pants when outdoors during increased mosquito activity times at dusk or dawn.


