# Remembering Bethany Comella

Bethany Comella came to Trail Works in January of 2015. This seemed only natural as she knew many Board members and their families. She joined our Board of Directors as treasurer from 2015 to 2019, serving two terms. Bethany next served as our vice president for two terms from 2019 to 2021, and she was voted in as our president from January 2021 to the end of 2023 when she was forced to step down because of her illness.

Bethany was dedicated to the promotion, signage, and maintenance of our 30 Passport trails, and completed walking them all, some on multiple occasions. In 2017, Bethany was a co-presenter at several State of the Passport Trails presentations at Wayne County libraries. In March 2018, Bethany did a public presentation of her trip to Ireland, and then hosted our group Christmas party in December 2018. As treasurer, Bethany advocated for best accounting practices and aligning our fiscal year with the calendar year, which happened in 2018.

Bethany maintained our Trail Works website, produced quarterly/semi-annual TWI-Lights newsletters, and set up our Square account for receiving membership dues and donations. She also contributed regularly to our Facebook page. Bethany encouraged us to schedule events as far out as possible to make sure we had an event each month. At one point, we had the entire year's events on our calendar by the end of January! She was so dedicated to Trail Works that while traveling abroad when she was president, she ran our monthly Zoom meeting from her hotel room!

Bethany's favorite Passport trails were the nature trails, including Huckleberry Swamp in North Rose and the Butterfly Nature Trail in Macedon, and she often hosted events at these two locations. This past June, she came up with the idea for a National Trails Weekend event, producing a 4-trail mini-Passport. Participants started at the Butterfly Nature Trail on a Saturday, had to complete two additional trails of their choice over the weekend, and then end up at Huckleberry Swamp on Sunday to complete the mini-Passport. Participants gathered again at Huckleberry Swamp to turn in their Passports and received a Trail Works T-shirt and a \$10 Wegman's gift card. It was a fun weekend, with a different twist on National Trails Day.

*My favorite Bethany memory involves her efforts to get a certain board member who was lax in turning in receipts for Trail Works expenses. Can you guess who that was? She kept after him and devised different strategies to try to keep him organized and on time, but eventually gave up and accepted the status quo.*

From Glenn Wallis

*When Bethany moved into her Lyons home adjacent to Taylor Park, we talked about getting a Pomeroy historic marker grant for the park where William Taylor's tannery and mail bag factory once stood. As I had recently been awarded grants for other Pomeroy markers, she was very hopeful that I would get one for Taylor Park. In my initial attempt, I came up with less than what I felt was needed to succeed and did not apply. Now, a couple years later, I am about to apply for the marker with what I feel is a strong case. When working on the project, I sometimes think of Bethany and wish she were here to talk to about my efforts.*

*My favorite memory of Bethany was when we took a walk together in 2022 at the Trail of Hope in Lyons. We were talking about how our list of "Dirty Thirty" finishers on the website needed to be updated (including adding her own name!) as more and more people were completing all 30 Passport trails. Then she confessed that she always wanted to complete the 30 trails again, but this time, in one 24-hour period! We had a good laugh with that one figuring we'd have to get up and start at 6am to have any hope of doing it. It was one of her good days.*

# Annual Meeting Highlights

The Trail Works Annual Meeting was held on January 23, 2024. We voted in new officers and board members. Vice President Mark DeCracker stepped up to President after the passing of Bethany Comella. He is filling the one year that was left on Bethany's term. In January 2025, we will need to vote in a new president for a two-year term. Current board members Sal Vittozzi and Glenn Wallis agreed to another two-year term. Holly Burgess was voted in as our new VP. We also voted in new board members Michael and Caleigh Shippers, frequent attendees at our hikes. Thank you to all for your continued interest and support of our Board!

Our Bylaws were also amended and voted on to include two changes which are briefly described below.

## Trail Works Dissolution Plan:

A plan for dissolution was discussed by the Board early in 2023. Last year, our board was made up of mostly seniors, some retired and some still working. We recognized that we were losing Board members. In addition, we were lacking younger people interested in working on our Board to carry the torch in the future. A committee was set up to discuss and come up with a plan in case we found ourselves with no alternative but to dissolve. The plan basically lists what needs to be done to dissolve a 501c3 non-profit organization. Our Bylaws were amended and voted on at the annual meeting, and we now feel confident and secure in what we need to do if we come to that point. Please be assured that we are not thinking about dissolving anytime soon, but just want a plan in place. Any move to dissolve the Trail Works organization would require a vote by our general membership. We are grateful to those continuing members on our Board and our new members who believe in the work we are doing for the trails in Wayne County.

## Rolling Membership:

The Trail Works membership year has always been January to December. When we received a new membership mid-year, it still expired in December. After some thought and organization by the membership committee, it was determined that a rolling membership would be best for our members. A rolling membership simply means your membership begins on the day it is purchased, and is valid for 365 days, expiring one year from the purchase date. This gives everyone a full year of membership. While we have been very flexible with our memberships in the past, this is more organized and spreads out the membership renewal process for the committee throughout the year. You will now receive an email in the month your membership needs to be renewed.

## Goals for 2024

We also assembled a list of goals for 2024. This includes things like increasing general membership, planned monthly events, outreach tables and presentations, liaison work, trail maintenance, and miscellaneous projects. A copy is available upon request.

# What's in Store for Beechwood State Park?

With Sal Vittozzi as told to Rich Ross and Nancy Snyder

Beechwood State Park has come a long way since Sal Vittozzi took over as Park Caretaker. The Town of Sodus website, <https://sodusny.gov/camp-beechwood>, shares a map, information on camping, and park rules to keep it in order for the next visitor. It also directs you to a list of the current events which can be found on Facebook at "Camp Beechwood State Park," which boasts over 2.5K friends. You may have even been involved in the addition of the John T. Faulks Memorial Pavilion, enjoyed a view of the lake, attended some of the events, and hiked a few trails. But what do we know about the future of the park?

In a two-hour walk and recorded interview with Sal on December 6, 2023, Nancy Snyder and I were able to pose a few questions regarding what the future of the park might be like. Sal was very excited and passionate about sharing some of his thoughts.

Early in the conversation, Part One of our interview with Sal published in our Fall 2023 newsletter, he discussed where he was from and how he got the job. He described all the tasks required of him as caretaker, which are many. This segment, we focused on what is in store for Beechwood State Park.

Q: Are you still enjoying it after six years, and what's your next challenge?

Sal: *It's getting to what I expected it would be. I didn't realize how tough it would be in the beginning because of all the other incidents that happened here at the park. And then I thought I was just coming into a campground doing maintenance, and that was what it was going to be. It ended up being a whole lot more!*

Q: How was last year?

Sal: *We got a decent amount of money from the camping fees, so that allowed me to get the building materials that I need and extra saws, so we did pretty good. We got the liner for the skating rink last year from the camping fees, and I'm getting the lumber for it this year. Now the park is kind of paying for itself instead of being a burden on the town and the taxpayers. With the camping fees coming in now, we'll be able to get a few new buildings back here. I've already talked to one guy, and he's got a sawmill and does custom buildings and sheds. He said he'd be willing to do a couple buildings for us for at a discount, and I'll set up new areas. It's going to be pretty good rebuilding the place.*

As we walked down the Ashgrove area, toward the new 4H benches, Sal told us a little bit more about what he's been doing.

Sal: *I've got two benches there and that's from the 4H project, and if I trim this tree out, I'm still trying to expand this all out. I'm working on the multiflora rose going up the trail now, and I've got Boy Scout troop #113 coming out and helping me on the last piece, and it'll be all clear and we'll keep moving this way.*



He pointed down the open field and stated, *"It was the pool area, and this is soon to be the Camp Beechwood Stage, and I want to build a little stage down here. People can sit up on the hill and we'll have some live music down here."*

*"While we don't have power down here yet, it's coming next year. We do have power in the park that will come to this middle section, so we'll be able to light the trail and have access for it here, but it's not going all the way down into the park."*



We walked into the Pixie Area out on the bluffs and approached a building shell.

Q: What do we have here?

Sal: *This is a work in progress. This is the last project we had here, putting a new metal roof on the building. This was an old cook's building. It had an awning here, but a tree fell onto it, and we cut that off. We took the walls apart. Unfortunately, sometimes when you leave spaces for people to hide or get away with stuff, it's easier when we just take the walls off and you don't*

*have to worry about anyone painting them. This is just another open-air pavilion now.”*

Q: Want to talk about some future plans here for Beechwood?

*Sal: Ok, so the grant that we received to develop the west half of the park...work for that is going to begin in the spring. So, we'll be putting in a new road where the Sprong's Bluff Road is over on the outside of the park. We'll have a parking lot over there, and we're clearing everything out and making trails. That side of the park will be bicycle friendly. I believe they're going to start in the spring as soon as the weather changes. Basically, it's going to double the size of the park. But that's alright... trails for mountain biking, hiking, XC skiing and everything; multiuse trails here.”*

**Note:** This is part of the State grant Sharon Lilla was involved with. The State and Town of Sodus will be involved with the project starting in 2024.

As we walked by the Highlands area, Sal pointed out the buildings that were just fixed up and received a new paint job.

*Sal: “We've put a couple of mulch beds around and we're going to put in new fire pits here, so each section of the park is currently being worked on.”*

*Sal: “When I first started, there was a previous grant that was going to add water and electricity into the park. The water main has been put in the center section of the park. And they'll use the rest of the money to put electricity in down there.”*



We headed down through the Larches section over to the Lodge.

*Sal: “The Lodge needs more funding than we have now, but we're anxious to move it up higher on the list as everyone loves this building and its fireplace inside.”*

*Sal: “From where we started to where we are today, it's something different. It's all families back here now, and Scout troops going great, you know?”*



We headed toward the pine forest as Sal told us a story about when he first started, when two brothers were dropped off at the park by their mother, who then promptly left. Sal and his girlfriend Chandra kept an eye out for them, and reported the boys came back regularly. One brother just had his first child. Sal called him “a Beechwood Baby.”

When asked what Trail Works or other groups can do for Beechwood?

*Sal: Just spread the word of what's going on here and keep taking in the donations when they come in. You're doing everything you can. And I appreciate it too! Absolutely! It takes a team effort to get something like this done.”*

# Trail News and Notes

## Third Creek Trail Bridge Washed Out

Our “branch manager,” Gary Abbott, has been busy on this trail improving signage, arrows, and moving the Passport post to a more user-friendly location on the trail. But more importantly, the small footbridge at the south end of the trail has been washed out yet again by the January/February rains and snow melt we have received.

Please be aware that if you want to go from one end of the trail to the other, the crossing over the creek using the bridge is currently unavailable. We are working with DEC to provide a better solution to this continuing problem.



## Beechwood Ice Rink

In mid-January, visitors to Beechwood State Park had the opportunity to use a very nice ice-skating rink constructed by our friend, Sal Vittozzi. Sal strung up colored lights for nighttime use. The ice lasted only as long as the cold temperatures...not too long.

Any donations of used skates can be made to the park in the future. While it’s been another frustrating winter for those of us who like to play in the snow, we’re hopeful that unlike this year and last, we will get a decent string of cold weather next year to try again.

## April 8 Solar Eclipse

On Monday, April 8, a truly remarkable event will occur in our area. Wayne County is in the path of totality of a solar eclipse, where the moon gets between the Sun and the Earth.

There are many events that will be happening in our area that you can participate in to experience this unusual event, or just sit in your own backyard!

Be aware that traffic in the area will be heavy, especially in Sodus Point, and other areas along the lakeshore where the view will be at a premium. This includes Beechwood State Park and Chimney Bluffs State Park.

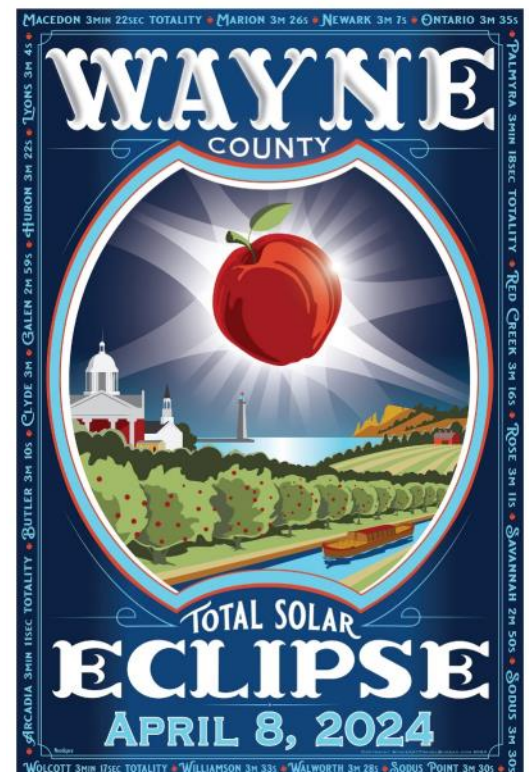

# Osceola Ski

I recently heard that this was the third lowest total for snowfall in Rochester, NY. It sure seems like it for someone like me who once skied a hundred days in a row in Wayne County. This year the only snowfall we received was the lake effect, and that has been extremely limited. Perhaps the best skiing was for the May's Farm ski event where we had over a foot of snow. It wasn't too long before it all disappeared. If there is snow, I will find it, and find it I did in Osceola, NY.

Osceola is just under a two-hour drive from Wayne County, but worth it. Osceola is near Redfield which receives probably the most snow in the northeast. Even in a snow drought year, they will have snow. Better yet, they have two Nordic resorts just two miles apart. The trails are wide and groomed every day. While skiing in Osceola, you feel like you are in the Adirondacks without driving too far. Both resort owners are friendly, and they offer great deals on skis.



On Saturday, February 24, 2024, I left Lyons where it was cold, and the ground was hard and brown. It was hard to convince any of my friends that there is plenty of snow just east of here. If you live out west in say, Colorado near Denver, you often need to drive a couple of hours to reach the snow in the mountains. So, I guess with these warm winters, we need to accept a little drive for paradise.

While I was skiing on this February day, I realized Nordic skiing is like a roller coaster ride, but instead of 30-second thrills, you get a two-hour ride. The best part is you get some wonderful exercise along the way. If you like peace and skiing with few people around, this is the place.



I did happen to cross paths with a gentleman named William Seyse, and we stopped to chat for a while. It reminded me of a day thirty years ago when I was on ski patrol for the Junior World cup in Lake Placid. It was cold, clear and a blue ski day just like the day I ran into Viktor Tkachenko. # The Crescent Trail

My wife Joan and I like to explore. We have visited many trails in and around Wayne County and far beyond. We sometimes pack a picnic lunch to carry with us. But often we plan to eat at a restaurant along the way. Finding a hike where there is a lunch stop takes some planning.

The Crescent Trail in Monroe County offers at least four options. To follow along, you may want to consult both the south and east section maps put out by the Town of Perinton:



map) and its many restaurants, cafés, and ice cream outlets.

Alternatively, you can approach from the south along the R.S.&E. Trolley Trail beginning either at Egypt Park or one of the three lots in Center Park. Here you must cross the pedestrian bridge over the canal to reach Fairport.

Two hikes begin at the parking lot on Garnsey Road (south section map) and have some ups and downs. Head north to eventually end up in Bushnell's Basin where there is a choice of restaurants.

This hike begins by winding along and just beyond neighborhood residences. There is a bit of climbing, especially in McCoord Woods (the high point) where the only alternative trail is found.

You can see from the map that many different hikes can be planned within the Crescent Trail system.

## First Day Hike at Casey Park 2024
